Extension Procedure

IMPORTANT DATES

• 18 Months Prior to Rule Sunset Date

60 Days from Receipt of Sunset Notification

Rule Filing Deadline Dates

Sunset Provision, W. Va. Code §29A-3-19

INCLUDES:

- The Secretary of State shall provide notice to the promulgating agency and LRMRC at least 18 months prior to the Legislative rule's termination date.
- The promulgating agency has 60 days from receipt of the notice to file the rule with the Secretary of State and LRMRC/LOCEA affirmatively seeking renewal.
- LRMRC/LOCEA may establish a procedure for timely review of the rule for agencies that have sought renewal prior to expiration.
- For rules seeking an extension of the sunset date only, no other changes or amendments can be accepted.
- Rule filings made solely for this purpose are not subject to the public comment period requirement.



NOTICE OF RULE SUNSET DATE

This notice is provided pursuant to W. Va. Code §29A-3-19(e).

Your agency's rule, title and series number, is set to expire in 18 months on <u>date</u>. According to W. Va. Code §29A-3-19(e), an agency has 60 days from receipt of this notice to formally file its intention to extend the rule's sunset date and, if affirmatively seeking renewal, a copy of the proposed renewed rule with the Secretary of State and the Legislative Rule-Making Review Committee (LRMRC).

The request for an extension of the sunset date allows for **only** the sunset date of the rule to be changed (along with the filling and effective dates). No other amendments or changes will be accepted. If any amendments or a repeal of the rule are desired, the agency must go through the full rule-making process set forth in W. Va. Code \$29A-3-1, et sec.

To satisfy your agency's duty under W. Va. Code § 29A-3-19, even if you are not requesting a sunset date extension, please log in to the Secretary of State eRules system and find the appropriate rule (listed above) in the "Your Agencies Sunsetting Rules" table. Go to the "Sunset Extension Request" field, complete and submit the form as instructed.

If your agency is requesting an extension of the sunset date without any amendments, you must

- 1. Request a New Rule Version in the eRules system;
- Upload the full text of the rule to the <u>Agency Approved</u> field with the 1.3. Filing date, 1.4. Effective date, and 1.5. Sunset date fields stricken-through;
- Add the following language to section 1.5: "This rule shall terminate and have no further force or effect upon the expiration of (the requested number) years from its effective data."
- 4. Attach the appropriate form(s); and
- 5. Submit the new rule for consideration by LRMRC.

This process will initiate the rule review. LRMRC is notified through the eRules system that the filing has been made, and your agency will be contacted if additional information is needed.

Again, if other amendments or a repeal of the rule are planned, you must go through the full rule-making process including the notice of public comment period.

18 MONTHS PRIOR TO THE SUNSET DATE

The Secretary of State will send an email to those with permissions in the Erules system for the sunsetting rule.

The email will notify the agency of the upcoming sunset date and provide instructions.


INSTRUCTIONS





Once completed, it gets submitted like a rule, first to Agency Head then to SOS



Once accepted, the Sunset Extension Request is viewable online with the "Active" rule in the Code of State Rules database.

LRMRC is notified through the Erules system that the request has been filed.

STEP 2

File the Agency Approved Rule

The Agency Approved filing must be done within 60 days of receiving the notification from the Secretary of State.

The Agency Will:

- Log in to eRules and request a new rule version for the rule.
- The new version file will be found in the "Your Agencies In-Progress Rules" table.
- Upload full text of the rule to the Agency Approved field.
- LRMRC will be notified and will access the rule through the eRules system.

TITLE 153 LEGISLATIVE RULE SECRETARY OF STATE

SERIES 876 SUNSETTING RULES EXAMPLE

§153-876-1. General.

- 1.1. Scope. This is a brief explanation of the rule sunset procedures.
- 1.2. Authority. W. Va. Code §29A-3-19.
- 1.3. Filing Date. October 11, 2015-
- 1.4. Effective Date. October 11, 2015.
- 1.5. Sunset Provision. This rule shall terminate and have no further force or effect upon October 11,2020. the expiration of 5 years from its effective date.

§153-876-2. Description of the beginning of a rule.

- 2.1. Everything above the General section of the rule is referred to as the introduction.
- 2.2. If it is a new rule, the filing and effective dates in the General section of the rule will be left blank until the rule is final filed.
- 2.3. If it is an amendment to an existing rule, the filing and effective dates in the General section of the rule will be struck through until the rule is final filed.
- 2.4. There is specific language that must be used for the Sunset Provision in the General section of the rule.
- 2.4.1. For all filings prior to the final filing, the language used shall be: "This rule shall terminate and have no further force or effect upon the expiration of (the number of) years from its effective date."
 - 2.4.1.a. For new rules, it shall be 5 years.
- 2.4.1.b. For an amendment to an existing rule, the number of years shall be determined by the agency and LRMRC.
- 2.4.2. Upon final filling the rule, the language shall be modified to: "This rule shall terminate and have no further force or effect upon (the actual date will be given).

THE RULE

The only allowable changes are the filing date, effective date and sunset date.

The dates in 1.3, 1.4 and 1.5 will be struck-through and the new requested sunset date will be added to 1.5 and underlined.



The Agency Approved form has been amended to ask if the filing is for the sole purpose of the sunset provision.


It then asks you to certify that the only changes to the rule are the filing date, effective date and an extension of the sunset date.




PUBLIC VIEW

RULE-MAKING PROCESS

Completing the Cycle

- 1. Filing the Sunset Extension Request form and the Agency Approved Rule will initiate the process.
- 2. The rule will be reviewed by LRMRC/LOCEA.
 - The agency will be contacted if additional information is needed.
- 3. The rule will be placed in a bill and considered during the Legislative Session.
- 4. Upon approval, the rule must be Final Filed.
 - The filing date, effective date and sunset date will be added to the General Section of the rule.
 - The language for the sunset provision, 1.5 must be "This rule shall terminate and have no further force or effect on (the actual date).

THINGS TO REMEMBER

- ❖ If additional amendments are needed for the rule, you must go through the full rule-making process including the Public Comment Period.
