ExpressVote counties,

Some of you already have something similar and some have asked about ballot privacy sleeves for your voters' ExpressVote ballots...while some haven't considered it yet b/c you've used iVotronics since 2006 and never had to deal with such issue.

Please see **attached pictures**. This privacy sleeve allows for voters who care about privacy to keep their vote secret (shhhhhh). Once they've voted on the ExpressVote and their printed ballot is returned to them, they can insert such ballot into the privacy sleeve before walking over to the DS200. Once there, the #'d ballot stub (which sticks out of the bottom of the sleeve) can be removed prior to feeding ballot into the DS200. The top of the sleeve has a slot which allows voters to push the ballot into the DS200 for tabulation.

Joe Wilson had the idea of utilizing the material we use for "end sheets" in our record storage binders; it's a durable polyurethane plastic that will hold up and last for years to come. If you are interested in these, please respond to this email or call our office to place an order with one of the girls. The cost is **\$3.50** each for standard (no lettering) or **\$4.50** each for customized stamping of **YOUR COUNTY** on each one. We are able to keep the cost down by making these in-house. Special thanks to Joe (for the concept) and Michael for being our hand model. 😊

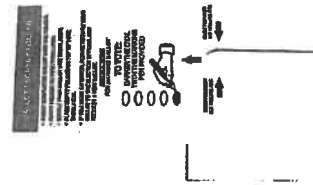

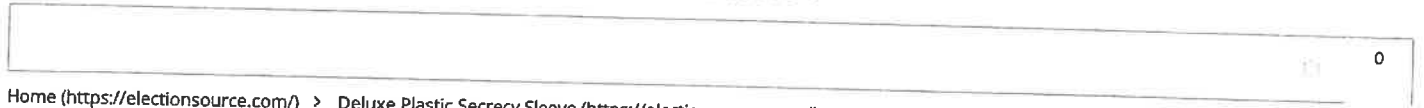
