<p style="text-align: center;">OFFICIAL BALLOT MINERAL COUNTY BRUNCH BILL ELECTION</p> <p>“Shall the beginning hour at which non-intoxicating beer, wine and alcoholic liquor be sold or dispensed for on premises consumption only in Mineral County on Sundays be changed from one o'clock p.m. to ten o'clock a.m.</p> <p>If approved by the voters this would allow private clubs and restaurants licensed to sell and dispense non-intoxicating beer, wine and alcoholic liquor; licensed private wine restaurants, private wine spas, private wine bed and breakfasts to sell and dispense wine; and licensed Class A retail dealers to sell and dispense non-intoxicating beer for on premises consumption only beginning at ten o'clock a.m. Additionally, if approved, it would also allow any mini-distilleries, wineries or farm wineries in this county to offer complimentary samples for on premises consumption only beginning at ten o'clock a.m.”</p> <p>Instructions to Voters: To vote in favor of the Brunch Bill, darken the oval next to "For".
