**Amendment No. 1:  
No Constitutional right to abortion  
Amendment**

**Summary of Purpose:** To amend the West Virginia Constitution to clarify that nothing in the Constitution of West Virginia secures or protects a right to abortion or requires the funding of abortion.

**Amendment No. 2:  
Judicial Budget Oversight Amendment**

**Summary of Purpose:** Providing that the total general revenue appropriations to the judiciary may be reduced in the budget bill, and setting forth the required procedures to be followed by the Legislature to enact any decrease in the total general revenue appropriations to the judiciary to an amount that is less than 85 percent of the amount of the total general revenue appropriations to the judiciary in the most recently enacted budget; providing that when requested by the Legislature, the Chief Justice of the Supreme Court of Appeals must appear and be heard and answer inquiries relative any budget bill; and conforming language relating to the introduction of the budget and matters that may be taken up during extended sessions to more recent amendments to the constitution.

**OFFICIAL LEVY BALLOT**

Election to authorize additional levies for the fiscal years beginning July 1, 2019, through and including July 1, 2023, in the approximate amount of \$2,967,000 annually, which amount is net of estimated delinquencies, exonerations, uncollectable taxes and discounts for the following purposes:

To pay all or a portion of the costs necessary for (i) the construction of a new building together with all necessary appurtenances and facilities for the purpose of housing the City of Wheeling Police Department, the City of Wheeling Fire Department and, depending on available space, other related City agencies specifically including but not limited to the following in connection therewith: demolition of existing structures, all necessary excavation and site work, the installation and construction of public utilities, the design, acquisition, construction and equipping of one or more buildings, the design, acquisition, construction and equipping of parking facilities and the acquisition of furniture, fixtures, equipment and other personal property in connection therewith (collectively, the "Public Safety Building") all to be located in The City of Wheeling (the "City"); (ii) the design, acquisition, construction and equipping of additions, betterments and improvements to one or more of the following existing Wheeling Fire Department facilities within the City: Station 2 (North Wheeling), Station 4 (South Wheeling), Station 5 (Wheeling Island), Station 9 (Warwood), Station 10 (Edgwood), Station 11 (Elm Grove) and Fire Department Headquarters (collectively, the "Fire Station Improvements"); (iii) the acquisition of a fire truck and related equipment (the "Fire Truck Acquisition"); and (iv) the payment, during the five year levy period, of all or a portion of the principal of, and interest on, certain lease revenue bonds (the "Bonds") which will be issued by the Wheeling Municipal Building Commission (the "Building Commission") to finance all or a portion of the costs of the Public Safety Building, the Fire Station Improvements and the Fire Truck Acquisition, to fund a reserve fund for the Bonds if funded from bond proceeds and to pay capitalized interest on the Bonds (collectively, the "Project"). In addition, funds may be used for costs associated with the service, maintenance, operation and equipping of the Public Safety Building, Fire Station Improvements and the Fire Truck Acquisition.

The total approximate amount of property taxes necessary to carry out the above purposes over the five-year levy period is \$2,967,002 annually, which amount is net of estimated delinquencies, exonerations, uncollectable taxes and discounts or a total approximate amount of \$14,835,010 for the five-year levy period beginning July 1, 2019, through and including July 1, 2023, all according to the order and ordinance of the City Council of The City of Wheeling entered on August 7, 2018. The additional rate of levy in cents upon each \$100 valuation on each class of property shall be as follows:

- Upon Class I Property 7.98 cents
- Upon Class II Property 15.96 cents
- Upon Class III Property 31.92 cents
- Upon Class IV Property 31.92 cents

The City Council of The City of Wheeling reserves unto itself as the levying body the right and authority to reduce the additional rates of levy if increased assessments would produce funds beyond projected needs in any year specified in this levy call in accordance with Chapter 11, Article 8, Section 6g of the Code of West Virginia, 1931, as amended.

The City Council of The City of Wheeling is hereby authorized and empowered to expend, during the term of this levy, the receipts accruing from the increased property tax levies, and such receipts may be used for the payment of costs of the Project (specifically including, but not limited to, the payment during the five year levy period of principal of, interest on and other costs associated with the above described Bonds) and the payment of costs associated with the service, maintenance, operation and equipping of the Public Safety Building, the Fire Station Improvements and the Fire Truck Acquisition.

In the event the City Council of The City of Wheeling shall obtain additional money by grant or otherwise from the state or federal government, or from any agency of either, or from any other source, for the purposes aforesaid, such additional money may be used either in substitution for, or in addition to, the sums obtained from such bonds and additional levies as the City Council of The City of Wheeling may from time to time determine.
