General Election to authorize additional levies for the fiscal years beginning July 1, 2019; July 1, 2020; July 1, 2021; July 1, 2022, to provide additional funds for: County-Wide Emergency Ambulance Service in Wayne County, West Virginia, is to be held according to the Order of the County Commission of Wayne County, West Virginia, entered on the 6th day of August, 2018.</p> <p>The additional levy on Class I, Class II, Class III and Class IV property is listed respectively following the purpose for which it is intended and is as follows:</p> <p>County-Wide Emergency Ambulance Service in Wayne County, West Virginia</p> <p>4.5, 9.0, 18.0, 18.0 cents per \$100 assessed valuation</p> <p>B.
