**Young Entrepreneurs Act:** House Bill 2897, effective **July 1, 2016** (West Virginia Code §59-1-2c), was passed and provides that any incorporator of an incorporation, member of a limited liability company, or partner of a partnership who is a West Virginia resident and is under 30 years of age to have their initial filing fee waived by the Office of Secretary of State, **if formed on or after July 1, 2016. You must provide proof of age and West Virginia residency, a driver's license or equivalent state or federal identification.
